What to do in a Psychiatric Crisis in Marion County, Indiana

A psychiatric crisis includes but is not limited to: a person who is suicidal or is having suicidal/homicidal thinking and/or behavior, acute psychotic symptoms, sudden change in mental status, violence, or who is gravely disabled and unable to manage his or her daily living. Below is information for persons in Marion County, Indiana that should help in dealing effectively with such a crisis.

5. Who is the *first* person a family/caregiver should call in a crisis in this county?

For medical or violent situations, call 911. For Mental Health/Chemical Dependency: contact current treatment provider, 911 or local mental health center: Gallahue Mental Health Services Crisis Line: 1-800-662-3445 or 317-621-5700; Midtown Mental Health 317-630-8485; Behavior Corp 317-574-1252; Adult and Child Mental Health 317-822-5122; or Mental Health America 317-251-7575.

6. What does this county advise the involved relatives/friends/neighbors of those in crisis to do for those who ARE COOPERATIVE?

If the person is in Mental Health/Chemical Dependency treatment, contact the treating therapist or psychiatrist. If medical crisis, contact the patient's Primary Care Physician (PCP) or call 911. If not in treatment you can call local crisis lines (see above listings) or be taken to Community Hospital North Psychiatric Pavilion, St. Vincent Stress Center, Wishard Hospital Emergency Room, Methodist Hospital Emergency Room or St. Francis Hospital Emergency Room for the patient to be assessed by a physician.

7. What does this county advise involved relatives/friends/neighbors of those in crisis to do for those who ARE NOT COOPERATIVE?

Call 911 or local police for assistance for imminent risk. You can also call the person's current mental health provider or local Mental Health Center. If the crisis is not life threatening and family can keep the person safe, they should contact the person's treating therapist/psychiatrist to see the patient; or local mental health office for assistance in getting an Emergency Detention Order filed.

8. What does this county recommend relatives/friends/neighbors of those in crisis to do if the person does not have a mental health care provider?

If the person is high risk, call 911 or local law enforcement. If s/he is not high risk, call a local mental health center.

10. How does this county handle a person in a psychiatric crisis who *refuses* voluntary placement, and his health care provider recommends hospitalization? Describe the process by which

petitions for emergency evaluation and/or involuntary hospitalization may occur without a judge?

Detentions may be faxed to the mental health court by: a local psychiatrist if psychiatrist has assessed patient and deemed them a danger. Family members may seek an Emergency Detention Order (EDO) by presenting information and documentation to a physician. Once physician signs EDO, family then takes petition to the mental health court for judge's ruling. Local law enforcement may place a person on an IDO based on observation of behaviors or treating therapist's recommendation with accompanying documentation that client meets criteria of dangerousness.

11. Describe the process by which petitions for emergency evaluation and/or involuntary hospitalization may occur with a judge

Families can seek an EDO through their Primary Care Physician (PCP) or the local mental health provider. Family must have documentation of client's behavior/thoughts that are reasons for inpatient psychiatric treatment. Once an EDO is completed and signed by a physician, family would take EDO to local probate court for Judge's ruling. The Judge then would issue an order to local law enforcement to pick up client and transport to appropriate facility.

12. How does one file a petition in this county during non-court hours?

An EDO can be filed after hours by a treating psychiatrist. Petitioner faxes completed paperwork to local mental health court. Family members cannot seek an EDO until mental health court opens on the next working day.

13. Do you have a Crisis Intervention Team (C.I.T.) in your area? These are emergency responders who are specially trained to handle mental health cases and to evaluate people in crisis.

Yes . Call Indianapolis Metro Police Dept. IMPD (317-327-3811) or Marion Co Sheriff's Department (317-327-1700) and ask for a CIT officer. They both handle qualified pick-ups.

14. Who handles the qualified pick-ups for involuntary holds?

15. Do you do face to face assessments after hours?

Yes, With Gallahue Crisis Team at Community Hospital North, Psychiatric Pavilion, 7150 Clearvista Drive Indianapolis, IN 46256 - See Question #9.

16. How does one get an emergency evaluation form/petition in this county?

Marion County courts, Mental Health Centers, some emergency rooms.

17. Where does one *file* a completed emergency evaluation form/petition in this county?

Marion County Mental Health Court. Complete an Emergency Detention Order (EDO), have physician sign, fax to court, they have the Judge sign and fax the EDO back.

18. Do you ask the caregiver bringing a patient to your care for any and all mental health history and/or recently observed behavior?

19. Is there a Mental Health America in your area? Do they assist with people in crisis?

Yes; their crisis phone number is 317-251-7575. It does not operate 24/7.
